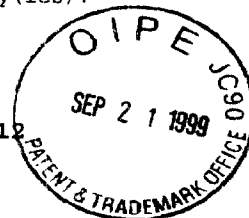

ASSIGNMENT

WHEREAS, **Edmond Ku of Sunnyvale, California 94087; Richard Huang of Mountain View, California 94041; Jenny Schlee of La Honda, California 94020; Joshua Morenstein of San Francisco, California 94117 and Sonja Schiefer of Palo Alto, California 94301;** has invented certain new and useful improvements in *Portable Computer Having Articulated Display With Notebook, Tablet and Presentation Display Modes*, for which invention I have executed an application for Letters Patent of the United States filed *June 16, 1999 as Serial No. 09/334,278* in the United States Patent and Trademark Office.


