ASSIGNMENT

WHEREAS, **Edmond Ku of Sunnyvale, California 94087; Richard Huang of Mountain View, California 94041; Jenny Schlee of La Honda, California 94020; Joshua Morenstein of San Francisco, California 94117 and Sonja Schiefer of Palo Alto, California 94301;** has invented certain new and useful improvements in *Portable Computer Having Articulated Display With Notebook, Tablet and Presentation Display Modes*, for which invention I have executed an application for Letters Patent of the United States filed *June 16, 1999 as Serial No. 09/334,278* in the United States Patent and Trademark Office.

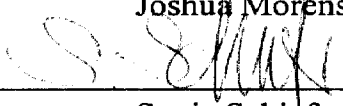
arrangement for any such application the date of the said United States application (or other application if any there be) in priority to other applications; and we do hereby covenant and agree with the said assignee that we will not execute any writing or do any act whatsoever conflicting with these presents, and that we will at any time upon request, without further or additional consideration, but at the expense of the said assignee, execute such additional assignments and other writings and do such additional acts as said assignee may deem necessary or desirable to perfect the assignee's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional renewal, reissued or extended Letters Patent of the United States or of any and all foreign countries on said invention, and in enforcing any rights or chose in action accruing as a result of such application or patents, by giving testimony in any proceedings or transactions involving such applications or patents, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of the assigns and legal representatives of both parties.
