

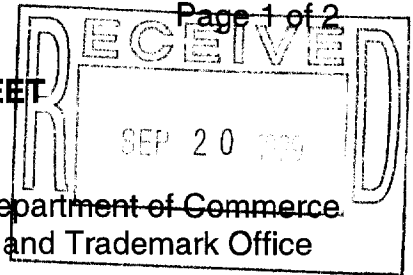

A S S I G N M E N T

have invented a new and useful process, machine, manufacture, composition of matter, or an improvement thereof, entitled:

AUTOMATIC SERIAL BUS TRANSMISSION SEQUENCER
