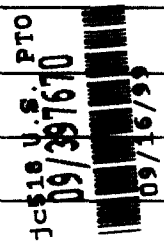

ASSIGNMENT

WHEREAS, I, Tetsuya ORI employed by FUJI PHOTO OPTICAL CO., LTD, 1-324 Uetake, Omiya City, Saitama 330, Japan have invented new and useful improvements in an IMAGE-READING LENS, for which I have prepared an application for Letters Patent of the United States of America;
