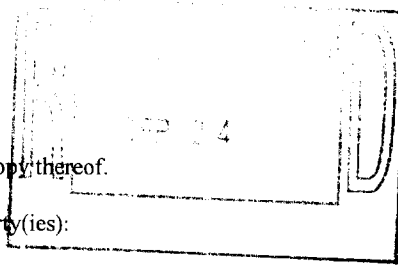

TWO STROKE, MULTIPLE CYLINDER ENGINE FOR SMALL VEHICLE
