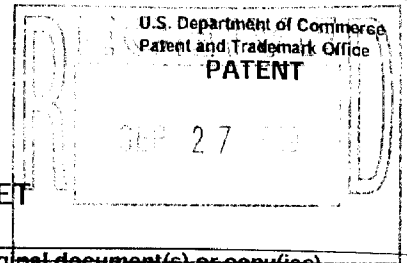




ASSIGNMENT
