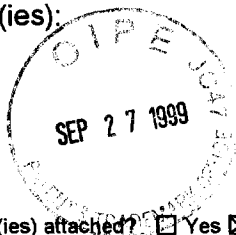

**ASSIGNMENT**

WHEREAS, we, Joseph David Blickhan of Quincy, County of Adams, and State of Illinois, and James Bruce Pickard, of Quincy, County of Adams, and State of Illinois have made new and useful improvements in CROWBAR CIRCUIT VERIFICATION TESTING SYSTEM;
