

WHEREAS, WE, Frank Schreiber and Peter Knauf, ASSIGNORS and citizens of Germany, residing at Oyweg 216,47546Kalkar, Germany; Am Tiefenberg 12, 40629 Düsseldorf, Germany, are the inventors of the invention in Pulverulent Filler and Method for Applying a Wear-Resistant Layer for which we have executed an application for a Patent of the United States; and
