ASSIGNMENT

WHEREAS, I, Wayne R. Moore, Ph.D., a citizen of the United States of America, together with Vidal E. Sotillo, Ph.D., a citizen of Venezuela , are residents of the Cities of Omaha and Atchison, respectively, Counties of Douglas and Atchison, respectively, and States of Nebraska and Kansas, respectively, and have invented a certain new and useful:

Method for Producing a Cat Litter from Grain Milling Byproducts

(f) any and all applications for Letters Patent upon said invention which may hereafter be filed in any and all countries foreign to the United States of America;

(g) any and all refilings, divisions and continuations of said foreign-filed applications;

(h) any and all Letters Patent of countries foreign to the United States of America which may issue from the said foreign-filed applications, refilings, divisions and continuations; and

(I) any and all extensions of, and additions to, said Letters Patent of countries foreign to the United States of America.
