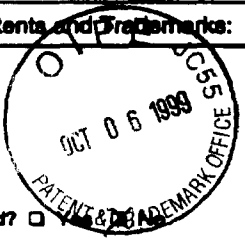

WHEREAS, TORSTEN JOHANSSON, a citizen of Sweden, residing at


