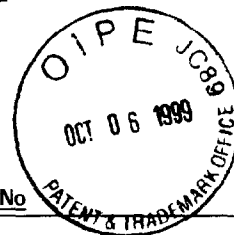

ASSIGNMENT

WHEREAS, WE, Farad AZIMA, Henry AZIMA, Martin COLLOMS, Graham BANK, and Nicholas Patrick Roland HILL, respectively residing at Flat 3, 1 Palace Gate, Kensington, London W8 5LS, Great Britain; 3 Southacre Close, Chaucer Road, Cambridge CB2 2TT, Great Britain; 22 Burgess Hill, London, NW2 2DA, Great Britain; 1 Boartree Way, Huntingdon, Cambridgeshire, PE18 6GL, Great Britain; and The Flat, 206 Cherry Hinton Road, Cambridge CB 14AW, Great Britain, have invented certain new and useful improvements in "ACTIVE ACOUSTIC DEVICES" for which an application for Letters Patent of the United States was filed January 20, 1999, and assigned Application Serial Number 09/233,037;

AND WE HEREBY authorize and request the Commissioner of Patents and Trademarks to issue all said Letters Patent to ASSIGNEE;


AND WE HEREBY warrant and covenant that we have the full right to convey the entire interest herein assigned and that we have not executed and will not execute any instrument or assignment in conflict herewith;

AND WE HEREBY agree to communicate to the ASSIGNEE or its representatives any facts known to us respecting said invention, to execute all divisional, continuation, continuation-in-part, reissue, and reexamination applications, sign all lawful documents and make all rightful oaths relating to said invention, and to testify in any judicial or administrative proceeding and generally do everything possible to aid the ASSIGNEE to obtain and enforce said Letters Patent in the United States when requested so to by the ASSIGNEE.


