ASSIGNMENT

Of: FABRIC CONTAINER LINER

From: Kathy Reed, an individual

To: Dallco Industries, Inc.

I, Kathy Reed, a citizen of the United States residing in Shade Gap, Pennsylvania, am an inventor of a new, original, and ornamental design for FABRIC CONTAINER LINER shaped to fit a square container with four scalloped flaps extending over each corner, each flap having two scallops and pearled edges and being slightly stiffened so that, when viewed from above, the liner resembles a shamrock, for which my co-inventors, Amy Rine and Barbara A. Sherman, and I are applying for Letters Patent of the United States by an application so titled;

For good and valuable consideration paid to me from Dallco Industries, Inc., a corporation of the Commonwealth of Pennsylvania having an address at 1155 Elm Street, York, Pennsylvania 17403, the receipt and sufficiency of which I acknowledge, by this Assignment;

I sell, assign, and transfer to Dallco Industries, Inc. my entire and undivided right, title, and interest in and to the invention of a new, original, and ornamental design for FABRIC CONTAINER LINER, any applications for Letters Patent of the United States filed on said invention and all rights appurtenant thereto and in all applications related thereto, including each of the following: the right to apply for any letters patents for said invention in the United States and all foreign countries, all other applications for letters patent on said invention, in whatsoever countries, including all divisional, renewal, substitute, and continuation applications based in

whole or in part upon said invention or upon said application or related thereto; all letters patent that may issue thereon in the United States and foreign countries and all reissues, extensions, renewals, divisions, or continuations of letters patent granted for said inventions or upon said applications, to the full end of the term or terms for which said letters patent may be issued; and every priority or other right accorded by every international convention, treaty, or agreement that is or may be predicated upon or arise from said invention, application and other applications or letters patent therefor, all to be held and enjoyed by Dallco Industries, Inc., its successors and assigns, all the same as I would have held and enjoyed had this Assignment not been made;

I authorize and grant the right to Dallco Industries, Inc. to file and prosecute patent applications in all countries for any part of said invention in my name or in the name of Dallco Industries, Inc. or otherwise, as Dallco Industries, Inc. may deem advisable under any international convention, treaty, or agreement or otherwise;

I authorize the Commissioner of Patents and Trademarks of the United States and the empowered officials of all other countries to grant, issue, and transfer any letters patent for the said inventions arising out of said applications to Dallco Industries, Inc., as assignee of my entire right, title, and interest therein, in accordance with this instrument of assignment;

I represent and warrant that there are no rights or interests outstanding inconsistent with the rights and interests granted herein; I covenant that I will not execute, grant, or transfer any rights or interests inconsistent herewith; I bind myself to execute and deliver to Dallco Industries, Inc., its successors and assigns, any further documents or instruments and to perform any further acts that may be deemed necessary to enable it, its successors and assigns, to file the said

applications for letters patent for the said invention in any country in which it may elect to file such applications, and to vest in Dallco Industries, Inc., its successors and assigns, the title herein conveyed and intended to so be conveyed, and to enable such title to be recorded in the United States and each foreign country in which each such application may be filed so that any patent issued thereon shall be issued to Dallco Industries, Inc., its successors and assigns; and I further covenant and agree that I will, upon request, communicate to Dallco Industries, Inc., its successors and assigns, any facts relating to the said invention and the history thereof known to me, and that I will testify as to the same in any interference or other litigation when requested to do so by Dallco Industries, Inc., its successors and assigns.
