**ASSIGNMENT**

WHEREAS, We, Michael A. Spohn, a citizen and resident of the United States of America, whose post office address is 112 Pine Ridge Lane, Butler, Pennsylvania 16001 and Keith Callen, a citizen and resident of the United States of America, whose post office address is 177 Sarver Road, Sarver, Pennsylvania 16055 (hereinafter collectively referred to as ASSIGNOR), have invented within the United States and own a certain invention entitled
