**ASSIGNMENT AND AGREEMENT IN AN APPLICATION FOR LETTERS PATENT

I authorize and empower said corporation, its successors, assigns or nominees, to make application for patent or other form of protection for said invention in its or their own name, or in my name, in any and all countries and to invoke and claim for any application for patent or other form of protection for said invention filed by it, the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it, and to invoke and claim such right of priority without further written or oral authorization from me.

I hereby consent that a copy of this assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file or like document which may be required in any country for any purpose and more particularly in proof of the right of the said corporation or its successors, assigns or nominees to apply for patent or other proper protection for said invention, and to claim the aforesaid benefits of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it.

I covenant with STRAINERT COMPANY, its successors, assigns, legal representatives, and nominees, that to the best of my knowledge the right, title and interest herein conveyed by me are free and clear of any incumbrance, and that I have full right to convey the same as herein expressed.
