

I request that any and all patents for said inventions be issued to TSSL in the United States and to TSSL in all countries foreign to the United States, or to such nominees as they may designate.

I agree that, when requested, I shall, without charge to TSSL but at its expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient in connection with said applications, patents, or other forms of protection.


