AND for the same consideration, the Assignor hereby covenants and agrees to and with the Assignee, its successors, legal representatives, and assigns, that, at the time of execution and delivery of these presents, the Assignor is the sole and lawful owner of the entire right, title, and interest in and to the inventions set forth in said application, and that the same are unencumbered, and that the Assignor has good and full right and lawful authority to sell and convey the same in the manner herein set forth.

AND the Assignor hereby requests the Commissioner of Patents to issue any and all said Letters Patent of the United States jointly in the names of the Assignor and the Assignee, as the assignees of said application.
