



AND SELLER HEREBY further covenants and agrees that he will communicate to the said Assignee, its successors, legal representatives and assigns, any facts known to it respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths, and generally do everything possible to aid the said Assignee, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.

AND SELLER HEREBY covenants that he has full right to convey the entire interest herein assigned, and that Seller has not executed, and will not execute, any agreement in conflict herewith.
