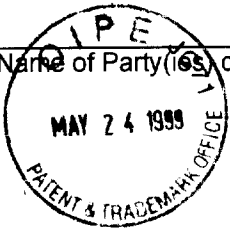

ASSIGNMENT



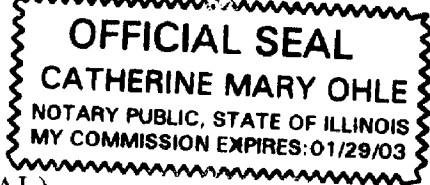
