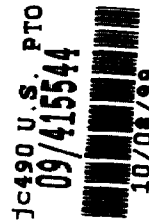

THIS ASSIGNMENT, made by me, Antonio Montalvo, a citizen of the United States of America, residing at 2627 Van Dyke Ave., Raleigh, North Carolina;

WHEREAS, I am the sole inventor of certain new and useful improvements in **DIFFERENTIAL AMPLIFIER WITH REDUCED EVEN ORDER NON-LINEARITY AND ASSOCIATED METHODS** for which an application for United States Letters Patent has been executed by me concurrently herewith, and
