WHEREAS, I, Jeffrey H. Sherman, citizen of the United States of America and resident of Dallas, Texas, has invented certain new and useful improvements in a "TREATMENT OF CONTAMINATED LIQUIDS WITH OXIDIZING GASES AND LIQUIDS" for which I am about to make application for United States Letters Patent, the said application having been executed on 10-14-99, and;



I hereby further agree that I will communicate to said ASSIGNEE, or to its successors, assigns, and legal representatives, any facts known to us respecting any improvements; and, at the expense of said ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, and make all lawful oaths, and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper patent protection for the invention in all countries.

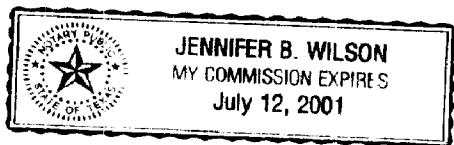
