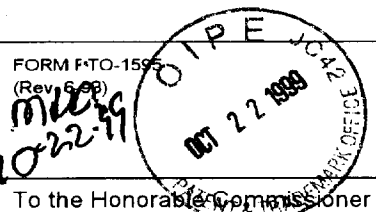


## ASSIGNMENT
