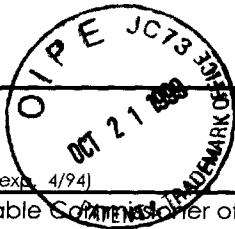

for which an application for Letters Patent of the United States was filed on August 18, 1999 and has been assigned U.S. Serial No. 09/376,520; and




