AND ASSIGNOR covenants that it has full right to convey the entire interest herein assigned, and that it has not executed and will not execute any agreement in conflict herewith, and further covenants and agrees that it will each time request is made and without undue delay, cause to be executed and delivered all such papers as may be necessary or desirable to perfect the title to said inventions or improvements, and said Letters Patent in said ASSIGNEE, their heirs, successors, assigns, nominees, or legal representatives, and agrees to communicate to said ASSIGNEE or to their nominees all known facts respecting said inventions or improvements, and said Letters Patent, to provide testimony in any legal proceedings, to sign all lawful papers, to execute all disclaimers and divisional, continuing, and reissue applications, to make all rightful oaths, and generally to do everything possible to aid said ASSIGNEE, their heirs, successors, assigns, nominees and legal representatives to obtain and enforce for their own benefit proper

patent protection for said inventions or improvements in the United States and its possessions and territories and in all other countries;
