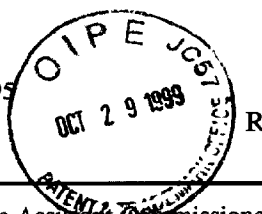


# ASSIGNMENT

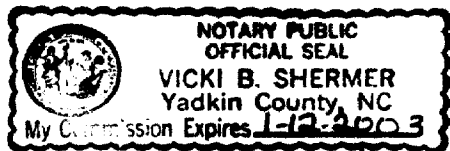

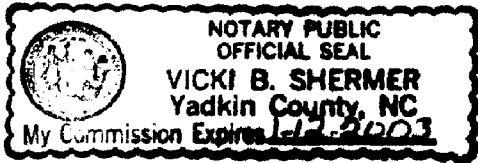
