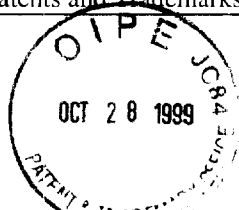

ASSIGNMENT

WHEREAS, John WIRTH, Jr., Jay L. SANGER, Paul BRUTSMAN, and Mark K. McCOOL, (hereinafter ASSIGNORS) of P.O. Box 867, Dubois, Wyoming 82513; 6780 Ridgecrest, Casper, Wyoming 82601; 1971 N.
