ASSIGNMENT

WHEREAS, we, **Jerry Hubert Ross and Eugene Clark Hayes**, employees of the United States Department of the Interior, **U.S. Geological Survey**, have invented a new and useful improvement in **METHOD AND APPARATUS FOR WATER LEVEL DETERMINATION** for which we have made application for Letters Patent of the United States of America, executed concurrently herewith (October 13, 1999) and further identified as Department of the Interior Case No. **SUR-3639/3646**, and

WHEREAS, the patent rights in said invention are assignable to the United States pursuant to the provisions of 43 CFR, Part 6, and other applicable laws and regulations, and

WHEREAS, the Government of the United States, as represented by the Secretary of the Interior, is desirous of acquiring the same application and any and all Letters Patent of the United States that may issue thereon;

NOW, THEREFORE, in consideration of these premises, our employment by the said Government of the United States and for other good and valuable consideration, receipt of which is hereby acknowledged, we, **Jerry Hubert Ross and Eugene Clark Hayes**, do hereby sell, assign, and transfer unto the Government of the United States, **as represented by the Secretary of the Interior, 1849 C Street NE, Washington, D.C. 20240**, the full and exclusive right in and for the territory of the United States of America, in and to the invention as described and claimed in said application, and in and to any Letters Patent that may issue upon said application, or on a division or continuation thereof;



The said license shall include the power to issue sublicenses for use in behalf of the Government and/or in furtherance of the foreign policies of the Government and/or in furtherance of any obligation entered into by the Government regarding the invention claimed in the said application.
