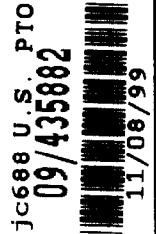





or upon said invention or applications unto the said FINGER-WEIGHT CORPORATION, its successors and assigns, in accordance with this assignment.






