I am the true and first co-inventor of an invention relating to

INJECTION MOLDED MOTOR ASSEMBLY AND METHOD OF FABRICATION

and I hereby agree, whenever requested, to communicate to the Assignee, its successors, assigns, and legal representatives, any facts known to me respecting said inventions, to testify in any legal proceeding, to execute all applications, papers or instruments necessary or required by the Assignee, its successors, assigns, and legal representatives to carry into effect any of the provisions of this instrument, and generally to do everything possible to aid the Assignee, its successors, assigns, and legal representatives to obtain and enforce proper patent protection for said inventions in any and all countries.
