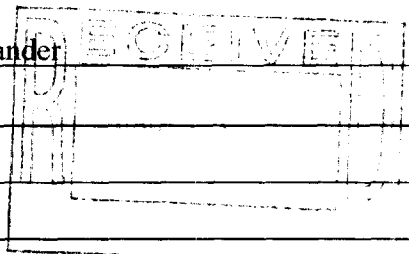

1. If Knute creates a company with the patent, Rachel and other interested parties will receive the percentage payments below.


2. If we sell and/or license the patent the percentage profits are divided as written on the excel sheets on the second page.

3. When and if the Design Foundry is sold, or is making a significant profit, Tom Findley will receive his initial investment of 5,000.00 back.

4. With this agreement Knute will be taking over ownership of the patent.

5. With this agreement, Knute will take what is left of the initial 20,000.00 investment, with the understanding that he will be paid 1/2 of 30.00 per hour. The rest of the hours will be compensated for Audrey, Rachel and Knute if and when the company is sold or the patent is making profits.

6. If I give up on the patent, or stop working on it for a period of one year, I agree to give ownership of the patent back to Rachel, keeping with our arrangement of percentage profits.

Proceeds to be divided into "Basic share" and "Developer's share" according to hours put in as shown below:			
The basic share is based on 3000 hours total put in before April 18, 1999.			
The 3000, a rough estimate, is fixed by agreement.			
The developers' share is based on total hours put in after April 18, with an additional fixed bonus of 500 hours.			
The developers' share will never go over 3000 hours, or 50% of the total.
