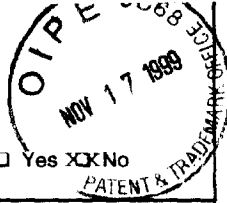

## A S S I G N M E N T

WHEREAS, we, Alex J. Severinsky, residing at 4707 Foxhall Crescent, Washington DC 20007, and Theodore Louckes, residing at 10398 Appomattox, Holly, Michigan 48442, have invented certain new and useful improvements in HYBRID VEHICLES INCORPORATING TURBOCHARGERS, as described in United States patent application Ser. FURTHER, we agree that we will communicate to PAICE Corporation, or its representatives, any facts known to us respecting said invention, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, substitution, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said PAICE Corporation, make all rightful oaths and generally do everything possible to aid said PAICE Corporation, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and in any and all foreign countries, with the understanding that PAICE Corporation shall pay us reasonable compensation for and expenses incurred in fulfillment of the obligations of this paragraph.
