

AND I do hereby authorize and request the issuing authority to issue any and all of said United States and foreign patents on said invention, inventions, or improvements to said COMPANY, its successors and assigns, as the assignee of the entire right, title and interest in and to the same, for the sole use and benefit of said UNIVERSITY, its successors and assigns.

AND I do hereby covenant and warrant that I have full right to convey the entire right, title and interest herein assigned free and clear of all licenses, encumbrances and liens whatsoever, and that I have not executed and will not execute any instruments in conflict herewith.

AND I do hereby covenant and agree to and with the said UNIVERSITY, its successors and assigns, that I, my executors, administrators, or other personal representatives, will do all lawful acts and things, make all rightful oaths, and make, execute, and deliver any and all other instruments in writing, and any and all further applications, papers, powers, affidavits, assignments, disclaimers and other documents, which in the opinion of counsel for said UNIVERSITY, its successors and assigns, may be required or necessary in this or in any foreign country more effectually to secure to and vest in said UNIVERSITY, its successors and assigns, the entire right, title and interest in and to said invention, inventions or improvements, application or applications, patents, rights, titles, benefits, privileges and advantages hereby sold, assigned, confirmed, transferred and conveyed.
