1. DEFINITIONS

1.1 "Assigned Patents" shall mean those certain patents set forth in Schedule A, attached hereto and incorporated herein by reference and any and all patents, whether U.S. or foreign, that are or may be granted therefrom, including without limitation any extensions, continuations, continuations-in-part, divisions, substitutions, reissues, reexaminations and renewals of any of the foregoing, or foreign equivalents thereof.

Subject to the terms and conditions of this Agreement, any licenses or rights granted by DG relating to the Assigned Patents in existence as of the Effective Date, and the rights retained by DG as set forth below in Section 3, DG hereby assigns, transfers and conveys to the Company all of DG's right, title, and interest throughout the world in and to the Assigned Patents (the "Assignment").

DG hereby retains a nonsublicenseable, nonexclusive, transferable, royalty-free, fully paid-up, perpetual, irrevocable, worldwide right and license under the Assigned Patents for DG to make, have made, use (including the right to practice any method which is involved in the use), sell (either directly or indirectly), or offer for sale any invention covered by any Assigned Patent, in standalone form or as incorporated in any DG product or service.


