**PATENT ASSIGNMENT**

WHEREAS I, MICHAEL MALLARY, a citizen of the United States of America, residing at 113 Boylston Road, Berlin, MA 01503, have invented improvements for a certain new and useful A SUSPENSION ASSEMBLY WITH ADJUSTABLE GRAMLOAD, for which I am filing an application for Letters Patent to the United States Patent and Trademark Office, said application having been executed by me on 10/27/59; and

foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said invention to the said QUANTUM CORPORATION, its successors, legal representatives and assigns, in accordance with this instrument.

AND I hereby covenant that I have the full right to convey my entire interest herein assigned, and that have not executed, and will not execute, any agreement in conflict herewith.

AND I hereby further covenant and agree that I will communicate to the said QUANTUM CORPORATION, its successors, legal representatives and assigns, any facts known to me respecting said invention and said applications, and testify in any legal proceedings, execute all lawful papers, make all rightful oaths and generally do everything possible to aid the said QUANTUM CORPORATION, its successors, legal representatives and assigns to obtain and enforce proper patent protection for said invention in all countries.
