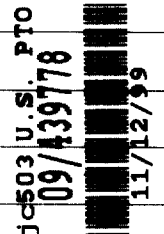

PATENT ASSIGNMENT

WHEREAS We, MAURICE SCHLUMBERGER, a citizen of France, residing at 620 Olive St., Menlo Park, CA 94025, and SERGE SHATS, a citizen of Russia, residing at 670 San Antonio Road, Palo Alto, CA 94306 have invented improvements for a certain new and useful "METHOD AND APPARATUS FOR EXTENDING CACHE HISTORY", for which we are filing an application for Letters Patent to the United States Patent and Trademark Office, said application having been executed by us on _____; and

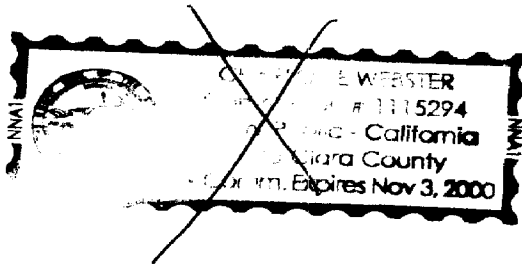
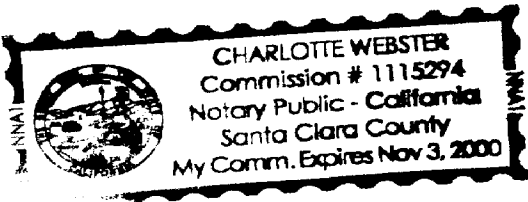


