

**ASSIGNMENT**

Oncor hereby authorizes Vysis to apply for, prosecute and maintain in its own name or in Oncor's name, as necessary, patents and like rights of exclusion and for inventors' certificates for inventions and improvements included in the Assignment Of Applications For United States Patents. Oncor further agrees for itself and its respective heirs, legal representatives and assigns, without further compensation to perform such lawful acts and to sign such further applications, assignments, Preliminary Statements and other lawful documents as Vysis may reasonably request to fully effectuate the assignment to Vysis of the aforesaid applications for United States Letters Patents and related rights.**
