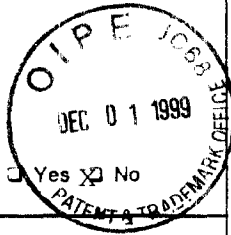

 to insert the said serial number and filing date when ascertained;


AND WHEREAS, FABIO PERINI S.p.A.,
