Gary M. Kimmel of **Cressona** in the County of Schuylkill and State of Pennsylvania,





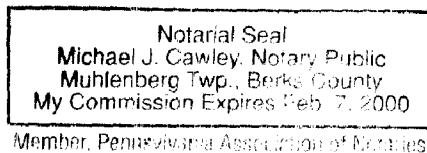
