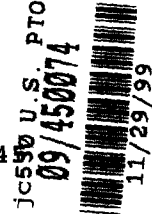

ASSIGNMENT AND AGREEMENT

WHEREAS, **Brian D. Lounsberry** of 207 E. Freistadt Road, Thiensville, WI 53092, and **Jonathan R. Schmidt** of 401 Highland Street, Wales, WI 53183, and **Steve W. Gravelle** of 11754 N. Solar Ave., Mequon, WI 53092, and **Michael S. Idelchik** of 10512 N. Beechwood Dr., Mequon, WI 53092, and **James S. Shepard** of 35 Stonebridge Road, Montclair, NJ 07042, (hereinafter referred to singly and collectively as "ASSIGNOR") have invented a certain invention entitled **METHOD AND APPARATUS FOR COMMUNICATING OPERATIONAL DATA FOR A SYSTEM UNIT IN A MEDICAL DIAGNOSTIC SYSTEM** (Atty. Dkt. No. 15-XT-5275 (70191-228)) for which an application for United States Letters Patent was executed by ASSIGNOR concurrently herewith; and

ASSIGNOR HEREBY AUTHORIZES AND REQUESTS the Commissioner of Patents and Trademarks to issue said Letters Patent to ASSIGNEE as assignee of the entire interest, for the sole use and benefit of ASSIGNEE, its successors and assigns.

ASSIGNOR HEREBY AGREES (a) to communicate to ASSIGNEE, its successors and assigns, or their representatives or agents, all facts and information known or available to ASSIGNOR respecting said invention or inventions, improvements, and modifications including evidence for interference, reexamination, reissue, opposition, revocation, extension, or infringement purposes or other legal, judicial, or administrative proceedings, whenever requested by ASSIGNEE; (b) to testify in person or by affidavit as required by ASSIGNEE, its successors and assigns, in any such proceeding in the United States or a country foreign thereto; (c) to execute and deliver, upon request by ASSIGNEE, all lawful papers including, but not limited to, original, divisional, continuation, and reissue applications, renewals, assignments, powers of attorney,


oaths, affidavits, declarations, depositions; and (d) to provide all reasonable assistance to ASSIGNEE, its successors and assigns, in obtaining and enforcing proper title in and protection for said invention or inventions, improvements, and modifications under the intellectual property laws of the United States and countries foreign thereto.




