



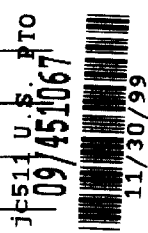

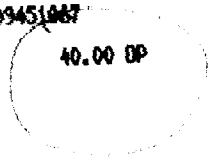

ASSIGNMENT
