ASSIGNMENT

WHEREAS, we, Herbert V. Kohler, Jr. of Kohler, Wisconsin; David J. O'Connell of Sheboygan, Wisconsin; Mary J. Reid of Sheboygan, Wisconsin; Erich D. Slothower of Sheboygan, Wisconsin; Carl F. We hereby warrant that we have the full right to make the conveyance herein. We hereby covenant that upon request we will communicate to said Company and its representatives all facts known respecting said inventions; execute all divisional, continuing, reissue, reexamination and foreign or international applications, together with individual assignments therefor; make all rightful oaths; sign all lawful papers; testify in any legal proceeding and generally do everything possible to aid said Company to obtain Letters Patent.

This Assignment and our promises herein also obligate our heirs, legal representative and assigns, and they are for the benefit of said Company and its successors and assigns.

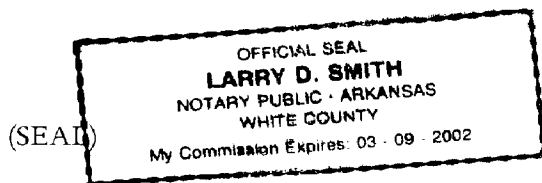
