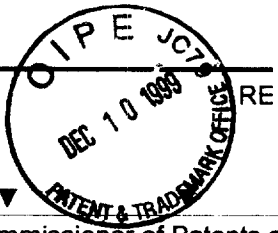

ASSIGNMENT

WHEREAS I, Cynthia Louise Ebner, residing at 102 North Staghorn Lane, Greer, SC 29650, have jointly with John Scott Hallock, residing at 10313 Coniston Court, Potomac, MD 20854, made an invention relating to Oxygen Scavenger Compositions, which invention is described in an application for Letters Patent of the United States entitled OXYGEN SCAVENGER COMPOSITIONS.


