NOW THIS INDENTURE WITNESSETH, That for a valuable consideration, the receipt whereof is hereby acknowledged, I hereby assign, sell and transfer unto the said Assignee, its successors, legal representatives and assigns, the entire right, title and interest in and to the aforesaid IMPROVEMENTS and in and to the inventions therein shown and described, including any and all further improvements heretofore or hereafter made, as well as in and to all patents United States or foreign, that may be granted for the inventions shown and described in the aforesaid applications for United States Letters Patent constituting a part of the aforesaid IMPROVEMENTS, and all improvements thereof, including any and all re-issues, continuations, divisions and extensions of said patents, in and to any and all priority and/or Convention rights or benefits accruing or to accrue to me with respect to the filing or securing of patents in the United States and/or any and all countries foreign thereto, and covenant that I have full right so to do, the same to be held and enjoyed by said Assignee for its own use and behoof and for its legal representatives, successors and assigns to the full end of the term or terms for which said Letters Patent may be granted as fully and entirely as the same would have been held by me if this assignment and sale had not been made;


And I hereby authorize and request the Commissioner of Patents and Trademarks to issue all patents on said United States applications and for the inventions thereof, in accordance with this assignment;

And I agree that I will communicate to said Assignee or its representatives any facts known to me respecting said IMPROVEMENTS whenever requested, and testify in any legal proceeding;

And I hereby grant to Assignee the right to apply in its own name for patents corresponding to the aforesaid IMPROVEMENTS in countries foreign to the United States;

And I further agree to sign and properly execute such necessary and lawful papers for applications for foreign patents, for subdivisions of any applications for patent, and/or, for obtaining any reissue or reissues of any Letters Patent which may be granted for my aforesaid inventions and to perform such further acts as may be required to carry out the intent of this agreement as the Assignee thereof shall hereafter require and prepare at Assignee's expense.
