WHEREAS, Yakov Kurtsman, of 1510 W. Schreiber, #3, Chicago, Illinois 60626, (hereinafter called the "ASSIGNOR"), is the sole inventor of certain new and useful improvements in COMMUNICATIONS EQUIPMENT RELAY RACK for a full description of which reference is here made to an application for Letters Patent of the United States executed by him on the date of execution of this Assignment; and
