**ASSIGNMENT CONCERNING
INTELLECTUAL PROPERTY RIGHTS AND AGREEMENT**

The Assignor, Michigan State University, whose address is 238 Administration Bldg., East Lansing, Michigan 48814-1046, is the owner by Assignment of U.S. Serial No. 09/110,782, filed July 6, 1998, which Assignment is recorded at Reel 9330 Frame 0679. The Assignees, Richard D. Reynnells and Cal J. Flegal, whose addresses are 16400 Bond Mill Road, Laurel, Maryland 20707 and 2351 Mt. Hope Road, Okemos, Michigan 48864, respectively, intend, if possible, to process a patent for the Intellectual Property and to license its use, provided that the Assignor and other developers assign any proprietary rights they may have in the Intellectual Property to assure the Assignees' exclusive rights.
