ASSIGNMENT

NOW, THEREFORE, to all whom it may concern, be it known that for and in consideration of the sum of One (\$1.00) Dollar to me in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, I have sold, assigned, and transferred, and by these presents I do sell, assign, and transfer unto TELEFONAKTIEBOLAGET L M ERICSSON my entire right, title, and interest in and to the invention disclosed in said application, for the territory of the United States of America, and in and to the application for United States Patent therefor, and in and to all patents of the United States issued or to be issued thereon, and in and to all reissues, divisions, continuations, and continuations-in-part thereof; and for the consideration aforesaid I agree to execute any and all papers necessary to vest in and to secure to TELEFONAKTIEBOLAGET L M ERICSSON the full and exclusive rights to the invention aforesaid in the United States; and I do hereby authorize and request the Commissioner of Patents and Trademarks to issue all future patents granted on said application, or on the subject matter disclosed therein, to the aforementioned assignee, its legal representatives, successors, and assigns.
