**ASSIGNMENT**

WHEREAS, Litton Precision Products International, Inc., hereinafter called the "Assignor", has made the invention described in Patent Cooperation Treaty Application PCT/EP97/04455, filed on August 29, 1996 and the United States Patent Application Serial No. 09/254,195, filed on February 26, 1999 and both entitled RESOLVER FOR GENERATING SIGNALS WITH REDUCED HARMONIC PORTIONS;


