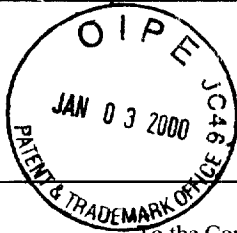



WHEREAS, CORVASCULAR, INC., a corporation duly organized under and pursuant to the laws of California and having its principal place of business at 490 San Antonio Road, Palo Alto, California 94306 (hereinafter referred to as the assignee) is desirous of acquiring the entire right, title and interest in and to said inventions and said application for Letters Patent of the United States, and in and to any Letters Patent or Patents, United States or foreign, to be obtained therefor and thereon:


