AND said assignor hereby requests the Commissioner of Patents to issue any reissue or extension of said Letters Patent or Patents of the United States to the said assignee, as the assignee of said inventions and the Letters Patent or Patents to be issued thereon for the sole use and behoof of the said assignee, his successors, legal representatives and assigns.
