**ASSIGNMENT**



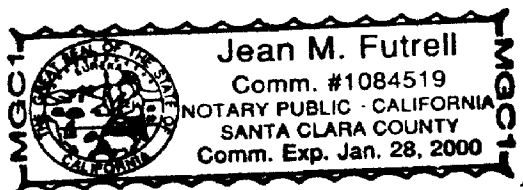
