ASSIGNMENT

WHEREAS, We, **Charles W. Francis**, a United States citizen, residing at 129 Sylvania Road, Rochester, New York 14618 and **Valentina Suchkova**, a Russian citizen, residing at 289 Farmview Drive, Macedon, New York 14502, have invented certain new and useful improvements in **A METHOD TO IMPROVE CIRCULATION TO ISCHEMIC TISSUE** for which we have executed an application for Letters Patent in the United States, filed as U. S. Serial No. **09/435,286** on **November 5, 1999**;

AND WE HEREBY covenant and agree that we will communicate to the said **University of Rochester**, its successors, legal representatives and assigns, any facts known to us respecting said improvements and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said **University of Rochester**, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.


